FY2023 SABS Modifications

No major changes have been made to the FY2023 SABS survey.

Web Based Training

Q. Where do we register for SABS training?

A. CPB offers pre-recorded, live webinar and workshop sessions for all Integrated Station Information System (Integrated Station Information System, AFR, FSR, Legal Form, SABS and SAS) related End User training. SABS Survey: General Ouestions:

Q. What if my station is unable to submit the SABS survey by the due date (February 15th)?

A. All CPB-supported grant recipients must complete questionnaires. CPB will not make the second payment for Fiscal Year 2023 CSGs until we have received the Fiscal Year 2023 Annual Financial Report (AFR), Station Activities Benchmarking Study (SABS) and the 2023 Annual Station Activity Survey (SAS); nor will CPB distribute 2024 grants prior to receipt of the survey.

Late filing of this survey could result in a reduction of your CSG payment, equal to 1/365th of the grant per day that the survey is late. If circumstances beyond your control require late submission of your SABS survey, you are now able to request an extension via the Integrated Station Information System website within your survey. Please note, that you must file separate SABS and SAS extensions if you require submission dates past the original due date.

Q. How do I request an extension for the SABS survey?

- A. Please follow these steps:
 - 1) Log into the Integrated Station Information System
 - 2) Scroll to the bottom of the summary page
 - 3) 'Click' the "Go to Main" button for SABS
 - 4) Expand the "Survey Status" area for SABS
 - 5) 'Click' the link "Extension Requests"
 - 6) Request an extension

<u>Please remember</u>, many stations think their audit needs to be completed before submitting the SABS survey. The SABS survey can also be completed without a finalized audit. If you think your financial numbers are 99% correct and you are simply waiting on the auditors to complete then please move forward and complete your SABS survey. If something major would change after you submit your SABS survey please send <u>SABS@cpb.org</u> an e-mail and we can make the update on your behalf. Having all SABS information submitted on time allows us to post the reports for station comparability.

Q. How many extensions can I request for the SABS survey?

A. You may request two extensions. The first extension is an automated 30 day extension if filed prior to the due date. The second extension requires an explanation and CPB approval. Also, please note that submitting your financial forms, SABS, and/or SAS surveys late will delay your 2nd CSG payment.

Q. I am unable to access the SABS survey in the Integrated Station Information System?

A. In order to access the SABS survey you will need to have the SABS Admin and/or SABS General security group added to your Integrated Station Information System profile. Your station's Grants Administrators, Head of Grantee and/or Licensee Official are the ONLY individuals that can make changes to the Integrated Station Information System security groups.

Q. Where should we report travel that is not related to professional development?

A. Unless otherwise stated, you should report all travel not related to professional development in the 'All Other' expense category for each functional area.

Station Information Section:

Q. For what time periods should we enter information into the SABS survey?

A. Unless indicated otherwise, you should enter financial and non-financial information for the fiscal year 2023 when reporting your answers to all other SABS survey questions.

Revenue Section:

Q. Where in the SABS survey should we report pass-thru revenue and/or expenses?

A. This situation applies mostly to state licensees, but is also possible for other types of licensees. If the state government or another entity gives you money that is 'earmarked' for purposes other than public broadcasting, please include the revenue in 'All Other' for questions # 2.1 and # 2.2 and the offsetting expenses in 'Other Activities and Services' for question # 3.1. (The revenue amount should equal the expense amount for a pass-thru contribution). Please remember that these amounts should only be reported if you report them on your station's audited financial statements.

Q. Where in the SABS survey should we report the CPB Interconnection grant?

A. This amount should be reported in the "All Other" row in question #2.1 and should not be reported in the "CPB CSG" row in question #2.1.

Q. Where in the SABS survey should we report Ready to Learn Grants revenue?

B. This amount should be reported in the Grant Solicitation (Competitive) row in question #2.1.

Expenses

Q. Where should we report our FCC renewal license expense?

A. For most licensees, this expense does not occur every year. We would ask that you report this expense within 'Other Activities & Services' in question # 3.1. Please remember to provide a description of the expenditures in question # 3.1 if you report expenses within 'Other Activities & Services' in question # 3.1.

Q. The instruction guide specifically says we should not allocate our General Management staff. How should Joint Licensees handle the General Management staff?

A. <u>TV Only licensees</u> should <u>not allocate their General Management staff outside of this subfunctional group. We highly recommend using the FTE Workbook to support the personnel portion of question # 3.1.</u>

Joint Licensees should not allocate their General Management staff outside of this sub-functional group either. If your General Management staff supports both TV and Radio then you should allocate their personnel expenses between the two operations. We highly recommend using the FTE Workbook to help your station perform the allocation splits between TV and Radio. Using the FTE Workbook should save you significant time when answering the personnel portion of question # 3.1.

Development Section:

Q. For Joint Licensees, how should we report donors/gifts that are contributed to both Radio and TV that we then allocate?

A. Please enter this as 1 donor/gift and record only that portion of the amount that was intended for or allocated to TV in the appropriate area of the SABS survey.

Q. Where in the SABS survey should we report Ready to Learn Grants expenses?

A. The amount of personnel and non-personnel expenses should be reported in the Grant Solicitation (Competitive) row in question #3.1 and you should also report the non-personnel expenses in question #5.7.

Programming Section:

Q. For Program Acquisition & Scheduling Expenses question #7.1 with respect to PBS expenses, how should we report the amount of PBS acquisition and our PBS Member Service Assessment (MSA) expenses?

A. The detail from PBS no longer provides the separation of the PBS acquisition expenses. Therefore, all direct & in-kind PBS acquisition expenses will be reported in question #7.1 as a subtotaled expense. Please report this amount in the 'PBS Programs – Total' row. The survey will still require that you break out the number of hours of Programming aired on the main broadcast channel (1 stream) and the number of hours of programming aired on all other broadcast channels.

Q. Where should we report the PBS Member Service Assessment (MSA)?

A. The invoice detail from PBS no longer provides the separation of the PBS Member Service Assessment (MSA) dues. Therefore, this is an expense that will be reported in question #7.1 in the 'PBS Programs – Total' expense row.

Educational Services and Community Engagement Sections:

Q. How do we determine the difference between Community Engagement and Educational Services?

A. <u>Community Engagement</u> extends the impact of public broadcasting through a variety of media services, engagement materials and collaborative activities. Efforts are generally in partnership with other community organizations and aim to engage individuals and foster community participation. Most often initiatives address specific issues of importance and target a particular segment of the population. Community Engagement Services include activities around programs such as *American Family, The Forgetting, Reading Rainbow, Town Forum, Health Issues*, etc.

<u>Educational Services</u> would include activities that have a formal curriculum based educational component involving schools and/or educators. Examples of these activities include *Ready-to-Learn*, *NTTI*, *K-12 educational resources*, Adult Basic Education, etc.
